- How are Things Going with Equity Use?
 - Elena talks using Access Equity System
 - Subcontractor usage and reporting and outreach module
 - There is an expectation to use Access Equity for subcontractor usage and reporting
 - Language is available to add to contracts involving this
 - Elena opens the discussion for others to share issues/concerns with potential subcontractor usage and reportage
 - Elena opens the discussion to Outreach Emails and asks others to share their experiences with direct outreach
- Megan Matthews- Director, Office of Equity
- Equity in Contracting Discussion
 - Megan introduces herself and gives a brief overview of her scope of work
 - Megan is working on removing barriers and improving outcomes for people across the state and currently working with agencies on issues with contracting systems

- Discusses the feedback that she has heard from small and micro businesses and how Office of Equity can help improve the system
 - Megan opens the discussion by asking for others to share what they've heard and to share thoughts and ideas
 - Megan asks about barriers on internal processes or policies that may be a concern
- Greg Tolbert– Legal Services Manager, Department of Enterprise Services
- Legislative Session Review
 - Greg shares a PowerPoint going over the legislative session this year
 - Greg discusses the timeline of this legislative season and what bills have passed and what they will impact
 - Goods and services contracts
 - Court interpreters, hydrofluorocarbons, language access providers, and prevailing wages
 - Public works contracts and procurement
 - Responsible bidder criteria, prime contractor bidding submission requirements, design-build projects – bonds, and prevailing wages
 - Other bills that impact contracts
 - Service contracts, EV batteries, transportation procurement (WSDOT), turfgrass seed contracts, photovoltaic module stewardship and takeback program, call centers, and transportation procurement (WSDOT)
 - Greg discusses bills that are dead but will likely come back next year for legislative session
- Olu Agbaje- Enterprise Procurement Policy & Protest Admin, Department of Enterprise Services
- Procurement Policy Updates
 - Olu provides an update on the policies and projects that are being worked on by the Policy Team
 - Delegated Authority Policy
 - Refreshing current policy that will align with the PRA
 - DES will be sending a survey to stakeholders to provide feedback and will help with revision
 - Procurement Risk Assessment (PRA)
 - PRA process is ongoing
 - There will be four sprints
 - Completed sprint one, getting ready for sprint two

- Katie Holder– Management Analyst, Department of Enterprise Services
 - WEBS Updates: Small Businesses, Winning Bids, Archiving, etc.
 - Katie discusses WEBS
 - Small business enhancements launch March 13th
 - Current state option in WEBS must select small, mini, micro, or not applicable
 - It will allow vendors to select their annual gross revenue, no. of employees and if owned and operated from all other businesses
 - This will help clarify who is a small business
 - When searching for a vendor, you will now see “SBO” is OMWBE small
 - Katie talks about award documents
 - Publicly post award and bid documents
 - Customers can add those documents in WEBS as part of solicitation documents
 - Bid calendar shows current solicitation opportunities
 - To add a spot to see the award documents on those solicitations
 - Archiving solicitations
 - Once a solicitation is closed, customers are not fully archiving their solicitations
 - Working on solutions on how to ensure those solicitations are archived and not just closed
